CHAPTER I - General provisions

- Art. 1. (1) For the purposes of this Regulation, admission refers to the set of rules, measures and activities that result in the enrolment of candidates declared admitted in the first year of studies in accredited or provisionally authorized bachelor's and master's degree programmes at Titu Maiorescu University (TMU).
- (2) The admission to bachelor's and master's degree programmes is done by admission examination, organized and conducted in accordance with art. 24 par. (8), art. 35, art. 38, art. 53, art. 56, art. 60, art. 94, art. 120 para. (2) M. h), art. 122 para. (6) of law no. 199/2023 on higher education, the Framework Regulation on the organization and conduct of admission to short-term university education, bachelor's, master's and doctoral degree programmes, approved by Order of the Minister of Education no. 3693/2024, as well as this Regulation.
- (3) This Regulation is supplemented by the Regulation on application to the admission examination for university and postgraduate study programmes for foreign citizens, Romanians living abroad and graduates of secondary/university education from accredited and recognised international systems, for the academic year 2024-2025, governing the application of candidates who are citizens of EU Member States, EEA, Swiss Confederation, third countries (NON-EU), Romanians living abroad, refugees, stateless persons and those under subsidiary protection in Romania, as well as high school/university graduates from international systems accredited and recognized by the Ministry of Education for admission to university and postgraduate programs of Titu Maiorescu University.
- Art. 2. (1) Admission to the first year is made within the limit of the number of students established by ARACIS and provided for by the GD for the academic year 2024-2025.
- (2) By exception to the provisions of para. (1), in duly justified cases, TMU may request an additional number of places within the limit of 10% of the enrolment figure established by ARACIS for a requested study programme intended for the schooling of European or EU third-country nationals or for academic mobility of students on the basis of governmental, university agreements or special programmes, under the terms of the law. TMU is required to inform ARACIS about the additional places received.
- (3) Enrolment for the places referred to in paragraph (2) may be made no later than the end of the first semester of the current academic year on the date of approval.
- Art. 3. (1) The admission examination to Romanian-taught degree programmes shall be held in Romanian. The admission examination for university degree programmes taught in a foreign language shall be held in the relevant teaching language.
- (2) The language skills of the candidates for the programmes with teaching in a foreign language are checked in accordance with the provisions of the own admission methodologies of the organizing faculties.
- Art. 4. (1) Candidates are required to pay an **application fee** for the admission examination, which can be paid in the following ways: a) in cash, at the TMU cash desk; b) by POS, at the TMU cash desk; c) online, through the TMU fee portal; d) in cash, at Banca Transilvania, using a pre-printed (payment transfer order/online transfer) e) by bank to the account RO90BTRL04301202N01816XX. opened Banca Transilvania. the at or to account RO49RNCB0546029228350001, opened at BCR, based on the payment codes, posted on the website www.utm.ro.

- (2) The admission examination fees, as well as the study fees and the due dates for their payment, are established by the Fee Nomenclature Regulation, approved last year the Board of Directors and the Senate.
- (3) The admission examination fee is not refundable under any condition (non-attendance, failure to pass, etc.).
- Art. 5 (1) Admission to bachelor's and master's degree programmes shall be organised, as a rule, in two sessions, under the same conditions for all candidates enrolled in the same degree programme, no later than 30 September 2024: the **July 2024 session** and the **September 2024 session**, for the places remaining vacant in the July 2024 session. The admission timetable shall be endorsed by the Board of Directors and approved by the Senate.
- (2) By way of exception to paragraph (1), admission to Level II of the Compact Psychopedagogical Training Programme organized by the Specialized Department with Psycho-pedagogical Profile of the TMU is organized before the start of the second semester of the academic year, according to the Structure of the 2024-2025 academic year.
- Art. 6. The TMU will inform candidates of the admission timetable, the conditions and documents required for enrolment, including the conditions and procedure for the recognition of diplomas obtained abroad, this Regulation, the annual tuition offer, the examination tests, the subjects and bibliography of the admission examination, special facilities or conditions (including for people with disabilities, specific learning difficulties or with special educational needs), the admission and tuition fees, and other useful information for candidates, by posting them at the Faculty's premises and on the website www.utm.ro.
- Art. 7. The organization of the admission examination for all study programmes of TMU can also take place online, upon the proposal of the faculty board, with the approval of the Board of Directors and the approval of the Senate in accordance with art. 32 para. (3) and art. 50, para. (3) from the Framework Regulation regarding the organization of admission examination to short-term higher education courses, Bachelor's, Master's and PhD courses, approved by Order no. 3693/2024 of the Minister of Education and with the special provisions contained in Chapter VI from this regulation.
- Art. 8. Based on the provisions of this regulation and the legal provisions, each faculty develops and adopts, through the decision of the faculty board, its own admission examination regulation. This will include, at least, the following: the examination tests, the theme and bibliography of the admission examination, the special facilities or conditions, measures regarding equal opportunities for people with disabilities, ensuring, where necessary, additional support adapted to specific needs, depending on specific to the study programme and the examination tests, (including for people with disabilities, with specific learning disorders or CES), admission and study fees, tie-breaking criteria (at least two) in the event that two or more candidates with the same overall average are in last place at the admission examination, the possibility of online support for the admission examination and the special procedure (if applicable), checking the language skills of candidates for programmes taught in a foreign language (if applicable).

CHAPTER II - Admission committees

- Art. 9 (1) A **Central Admission Committee** is established at the TMU level, which ensures compliance with the provisions of this Regulation and coordinates all the activities of the admission committees at the faculty level. The Central Admission Committee is composed of the Rector, as President, the Vice-Rector responsible for the educational activity, the Vice-Rector responsible for international relations, a Vice-President of the Board of Directors, the Secretary General of the University, the Director of the IT&C Department and the Administrative Director.
- (2) At the level of each faculty, at least two committees are established: **the Faculty Admission** Committee and the Committee for the analysis and resolution of appeals.
- (3) **The Faculty Admission Committee** organizes, conducts and has full responsibility for the admission examination at the faculty level, in all its stages, starting with the registration of the candidates and ending with the enrolment of candidates and ending with the posting of the final results. The Faculty Admission Committee is composed of the Dean as Chairman, the Vice-Dean, the Head of Department, the Head Secretary of the Faculty and, where appropriate, other senior faculty members, so that the number of committee members is uneven.
- (4) The Committee for analysis and resolution of appeals receives, examines and decides on appeals concerning the results of the written examination and/or the calculation of the overall admission average, as appropriate. The Committee for the analysis and resolution of appeals is composed of 3 members, faculty teaching staff other than those who are part of the Faculty Admission Committee and the Committee for the marking of written work.
- Art. 10. (1) The following **specialist committees by study programme** are established and operate at the Faculty of Medicine, Dental Medicine, Pharmacy, Nursing Targu Jiu and Psychology:
 - Committee for the preparation of topics and marking scales for the written paper;
 - Committee for the marking of written work;
 - Committee for the analysis and resolution of appeals concerning the results of the written work. Members of the committee for the analysis and resolution of appeals regarding the results of written tests cannot be part of the committee the marking of written work.
- (2) Each committee referred to in paragraph (1) shall consist of a chairman, members and a secretary. The chairman of the committee must have at least the academic rank of university lecturer. The secretary of the committee shall have only document management duties.
- (3) The organisation and conduct of the written examinations shall be carried out by academic staff as room heads and supervisors appointed by the faculty admission committee.
- Art. 11. The nominal composition of the admission committees at faculty level and of the specialist committees by study programmes is suggested by the faculty board, approved by the Senate and appointed by decision of the Rector. The Vice-Rector in charge of the educational activity ensures that an excerpt of the Rector's decision is drawn up and sent to the Dean of the Faculty.
- Art. 13. The members of the admission committees and of the specialist committees by study programmes may not be in a relationship with the candidates or with each other as spouses, kinsmen or relatives up to the third degree inclusive, according to the law.
- Art. 14. The membership of the committees referred to in Art. 9 para. (2) and art. 10 para. (1) may be changed after the appointment of their members by decision of the Rector only in exceptional circumstances, duly justified by the Faculty Board.

CHAPTER III - Candidates for admission

- Art. 14. (1) Only high school graduates with a baccalaureate diploma issued in Romania or a diploma equivalent to it, regardless of the year of their high school graduation, may apply for admission to the bachelor's degree programme.
- (2) Only graduates of Bachelor's degree studies with a bachelor's degree awarded in Romania or a degree equivalent to it, regardless of the graduation year, may apply for admission to the master's degree programme.
- Art. 15. (1) Nationals of the European Union Member States, of States belonging to the European Economic Area and of the Swiss Confederation, and British nationals and their family members, as beneficiaries of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community 2019/C 384 1/01, refugees, stateless persons and those under subsidiary protection in Romania may participate in the admission to bachelor's and master's degree programmes and postgraduate programmes under the same conditions as those provided by law and by this methodology for Romanian citizens, including the admission application and tuition fees. For these categories of citizens, the recognition of studies is done by the National Centre for the Recognition and Equivalence of Diplomas of the Ministry of Education.
- (2) Foreign citizens from third countries may apply for the admission examination by paying the fee in their own foreign currency, on the basis of a request for obtaining a letter of acceptance to study in Romania, issued by the Directorate General for International Relations and European Affairs of the Ministry of Education.
- (3) The application procedure for the candidates referred to in para. (1) and (2) shall be subject to the Regulation referred to in Art. 1 para. (3) of this regulation.
- Art. 16. Romanian citizens who have been admitted to bachelor's, master's and postgraduate programmes may enrol only on the basis of their baccalaureate or bachelor's degree.
- Art. 17 Candidates applying to the admission examination with the citizenship of a third EU state and who, as students, obtain Romanian citizenship during their university studies shall pay the tuition fee established by the Fee Nomenclature Regulation for students from third EU states.
- Art. 18. As an exception to the provisions of Art. 17, in case of change of citizenship status, upon the student's request, approved by the Vice-Rector responsible for international relations, the Board of Directors may approve the payment of the tuition fee for Romanian citizen students, established by the Fee Nomenclature Regulation.
- Art. 19. A candidate may be admitted and enrolled as a student in no more than two university study programmes simultaneously, regardless of the study cycle and the higher education institutions offering them.
- Art. 20. Candidates to bachelor's degree studies who have obtained, during their high school studies, distinctions (1st, 2nd, 3rd prizes in international school Olympiads recognized by the Ministry of Education and/or 1st prize in national Olympiads, financed by the Ministry of Education), have the right to apply, without taking the admission examination, provided that the distinctions and prizes have been obtained in subjects in the field of the study programme chosen.
- Art. 21. (1) The following are exempted from the payment of the application fees for the admission examinations to TMU:
 - children of teaching and auxiliary teaching staff in active service or retired;
 - children with one or both deceased parents;

(2) Exemption from the payment of these fees is made only on the basis of supporting documents submitted by the candidates (certification, death and birth certificate, etc.). The approval of the exemption, based on these documents, is made by the admission committees of each faculty.

CHAPTER IV - Admission examination tests

- Article 22. (1) Admission is made by study programmes and types of education, in descending order of the overall averages obtained by the candidates in the admission examination, within the limit of the enrolment figures established by ARACIS and provided by the GD for the academic year 2024-2025.
- (2) Under the conditions laid down in Article 2(2). (2), if for a study programme TMU receives approval from the Ministry of Education for an additional number of places for the enrolment of European or third country EU citizens or for academic mobility of students within the limit of 10% of the enrolment figure established by ARACIS for the programme in question the places will be taken only by candidates who have passed the admission examination, as follows: within the limit of the enrolment figure established by ARACIS, for Romanian citizen candidates and within the limit of the additional number of places approved, for foreign citizen candidates.
- Art. 23. (1) For the Medicine and Dental Medicine university degree programmes (*jointly comprising bachelor's and master's degree programmes and being regulated at a sectoral level*), the examination subjects are BIOLOGY (compulsory) and, optionally, CHEMISTRY or PHYSICS. The examination test consists of completing a 100-question multiple choice test, of which 70 for the compulsory subject and 30 for the optional subject. Each question has five possible answers. There are two types of questions:
- a) questions with one correct answer out of five. Each question marked with the correct answer and only the correct answer is marked with one point;
- b) questions with two correct answers out of five. Each question for which both correct answers are marked, and not others, are marked with one point.

The question booklets and the answer form shall specify the type of question. The overall average for the admission examination is calculated as follows:

$overall\ average = \underline{biology\ score} + \underline{score\ for\ the\ subject\ of\ your\ choice}$

The overall average for the admission examination is calculated with two decimal places, without rounding, and may not be less than 5 (five).

- (2) Candidates must specify on the Application form for admission examination and bachelor's degree programme enrolment for the academic year 2024-2025 the subject of their choice for the admission examination.
 - (3) The recommended textbooks and topics are given in ANNEX 1 to this Regulation.
- Art. 24. (1) For the Nursing (București and Târgu Jiu) and Dental Technology bachelor's degree programmes, the subject of the examination is BIOLOGY. The examination test consists of a 100-question multiple choice test. Each question has five possible answers, only one of which is correct. Each question for which the correct answer is marked, and not another one, is marked with 1 point. The score is converted into a mark as follows:

multiple choice test mark = <u>number of points obtained</u>

The mark obtained in the multiple-choice test must be a minimum of 5 (five). The overall average obtained in the baccalaureate examination or equivalent is taken into account in determining the overall average in the admission examination, with a weight of 10% of the overall average. The overall average for the admission examination is calculated as follows:

overall average = 0.9 x multiple choice test score + 0.1 x overall average obtained in the baccalaureate examination

The overall average for the admission examination is calculated with two decimal places, without rounding.

- (2) The recommended textbook and the topics are presented in ANNEX 1 to this Regulation.
- Art. 25. (1) For the Medicine in English and Dental Medicine in English university degree programme (jointly comprising bachelor's and master's degree programmes and being regulated at a sectoral level), the examination subjects are BIOLOGY compulsory and, as an option, CHEMISTRY or PHYSICS. The examination test consists of completing a 60-question multiple choice test, of which 40 for BIOLOGY and 20 are for the optional subject (CHEMISTRY or PHYSICS). Each question has 5 possible answers, only one of which is correct. Each question for which the correct answer is marked, and not another one, is marked with 1 point. The overall average for the admission examination is calculated as follows:

$overall\ average = \ \underline{biology\ score}\ + \ \underline{score\ for\ the\ subject\ of\ your\ choice}$

- (2) Based on the decision of the Faculty Board, the admission examination for all candidates can be held **online**, in which case the candidates receive in electronic format the multiple-choice test described in paragraph (1).
- (3) Candidates must specify on the Application form for admission examination and university degree programme enrolment for the academic year 2024-2025 the subject of their choice for the admission examination.
 - (4) The recommended textbooks and topics are given in ANNEX 1 to this Regulation.
- Art. 26. (1) For the Pharmacy university degree programme (jointly comprising bachelor's and master's degree programmes and being regulated at a sectoral level), the subject of the examination is CHEMISTRY. The examination test consists of a 20-question multiple choice test. Each question has four possible answers, only one of which is correct. Each question for which the correct answer is marked, and not another one, is marked with 0.5 points. The score is converted into a mark as follows:

chemistry mark = score *obtained x* 0.5

The mark obtained in the multiple-choice test must be a minimum of 5 (five). The overall average for the admission examination is calculated with two decimal places, without rounding, between the mark obtained at the multiple-choice test and the overall average obtained at the baccalaureate examination or equivalent.

- (2) The recommended textbook and the topics are presented in ANNEX 1 to this Regulation.
- Art. 27. (1) For the Psychology (Full-time education) and Psychology (Part-time education) bachelor's degree programmes, the subject of the examination is PSYCHOLOGY. The examination test consists of a 25-question multiple choice test. Each question has three possible answers, only one of which is correct. Each question for which the correct answer is marked, and not another one, is marked with 1 point. The score is converted into a mark as follows:

The mark obtained in the multiple-choice test must be a minimum of 5 (five). The overall average for the admission examination is calculated with two decimal places, without rounding, between the mark obtained at the multiple-choice test and the overall average obtained at the baccalaureate examination or equivalent.

- (2) The recommended textbook and the topics are presented in ANNEX 1 to this Regulation.
- Art. 28. (1) For the Informatics (Full-time education) and Psychology (Part-time education) university degree programmes, in the calculation of the overall average at the admission examination, are taken into account the overall average obtained at the baccalaureate exam or equivalent, with a weight of 2/3, and the average for the high school years of study, with a weight of 1/3, according to the following calculation formula:
- (2 x Overall average at the baccalaureate examination or equivalent + Average for the high school the years of study)+3
- (2) The average for the high school years of study and the overall admission examination average provided for in paragraph (1) is calculated with two decimal places, without rounding.
- Art. 29 For the Full-time and part-time Bachelor's degree programmes of the Faculty of Law, Faculty of Economic Sciences, Faculty of Economic Sciences, Faculty of Education Sciences, Communication and International Relations and the Faculty of Law and Economic Sciences Târgu Jiu, the overall average at the admission examination in the Bachelor's degree programme is:
- a) the arithmetic average between the overall average obtained at the baccalaureate examination and the mark obtained in the written test of the Romanian language within the baccalaureate examination, for candidates who attended high school studies in Romania, in the national education system.
- b) the arithmetic average between the overall average obtained at the baccalaureate examination (equated in the Romanian grading system) and the average of the marks obtained in the first foreign language (different from the official language in which the studies were carried out) during high school studies (equated in the Romanian grading system), for candidates who attended high school outside of Romania or in Romania in another education system.
- (2) The overall averages for the admission examination provided for in paragraph (1) is calculated with two decimal places, without rounding.
- (3) The admission to the Bachelor's degree programme PEDAGOGY OF PRIMARY AND PRESCHOOL EDUCATION, organized within the Faculty of Communication Sciences and International Relations, is conditioned by the passing of an eliminative vocational test, which consists of: a) motivational interview (oral test), on basis of an interview guide, and b) verification of diction and musical skills.
- Art. 30. (1) The examination test for admission to the Master's degree programme is an interview (oral test), conducted on the basis of an interview guide specific to the relevant field/programme. The interview is held in front of an interview committee, composed of an odd number of permanent teaching staff, appointed by decision of the faculty board. Each member of the committee awards marks from 10 (ten) to 1 (one), the mark of the test being the arithmetic average, calculated to two decimal places, without rounding, of the marks awarded by the committee members. The mark obtained in the interview must be at least 5 (five).

- (2) By way of exception to the provision of para. (1), based on the decision of the Faculty Board, the interview may be held online using the Microsoft Teams platform. All members of the interview committee must be present simultaneously on the platform throughout the interview. The candidate is required to have the video camera and microphone open during the entire examination.
- (3) The online interview shall be recorded in full for each candidate and archived in secure spaces and on secure memory drives under the coordination of the IT Department. The recording remains confidential.
- (4) Candidates will be asked to agree in writing to the recording of the online interview as part of their application file.
- (5) Before the start of the online interview, the candidate is required to identify himself/herself by showing his/her ID card to the video camera.
 - (6) It is forbidden during the online interview:
 - the presence/access of another person in the place where the candidate is being interviewed;
 - communicating with any other person during the interview other than members of the committee:
 - recording the candidate's examination performance;
 - sharing the candidate's screen with other people;
 - leaving the interview area;
 - interruption of the examination by the candidate
- (7) Failure to comply with any of the prohibitions referred to in paragraph (6) shall result in the interruption of the examination and notification of its fraud.
- (8) If for technical reasons (power failure, lack of internet connection, etc.) the candidate is unable to access the online interview platform, the examination committee may approve the rescheduling of the interview to another time during that day, without disturbing existing appointments.
- (9) In determining the overall average of the admission examination to the Master's degree programme, the overall average obtained in the Bachelor's degree examination shall be taken into account with a weighting of 25% of the overall admission average. The overall average of the admission examination is calculated with two decimal places, without rounding and cannot be less than 6 (six).
- Art. 31. The admission regulations of the faculties must provide tie-breaking criteria (at least two) for the case where two or more candidates with the same overall average are in the last place at the admission examination.
- Art. 32. In the case of candidates who attended secondary school/university studies outside Romania or in Romania, in another system than the national one, the overall average of the baccalaureate examination or equivalent, the marks obtained in the first foreign language during secondary school studies and the overall average obtained in the bachelor's degree examination, provided for in art. 21-25, shall be equated in the Romanian marking system by a committee for the equivalence of marks/qualifications obtained at the end of secondary school, other marks obtained during the secondary school years, as well as marks/qualifications obtained at the end of university studies, appointed by decision of the Rector.
- Art. 33. Admission of candidates to Level I (initial) during Bachelor's degree studies to Level II (advanced) during Master's degree studies as well as to the Compact Program with postgraduate regime, Level I and Level II, organized by the Specialized Department with Psycho-Pedagogical Profile, is based on giving an interview (oral test) which takes into account the communication, digital and relational skills necessary to complete a didactic training programme, evaluated with the admitted or rejected qualifications. The interview is held in front of an interview committee made up of an uneven number of tenured teaching staff and a secretary; the secretary only has the authority to

administer the documents. The nominal component of the interview committee is approved by the Senate. Following approval by the Senate, the committee is appointed by decision of the Rector.

- (2) By way of exception to the provision of art. (1), based on the decision of the Council of the Faculty of Education, Communication and International Relations, the interview can be held online, using the Microsoft Teams platform, respecting the provisions of art. 27, para. (2)-(7).
- (3) The admission of candidates to postgraduate study programmes and to the Romanian Language Preparatory Programme for foreign citizens is based on the registration files (including online).

CHAPTER V - Registration of candidates

- Art. 34. (1) Registration for the admission examination shall be made in person, on the basis of the identity card or passport and other documents provided for in this Regulation, or by proxy, on the basis of a notarized power of attorney.
- (2) The registration for the admission examination can be done online, by uploading the documents (scanned) by the candidates on the TMU's 2024 ADMISSION portal, which can be accessed directly from the link https://admitere.utm.ro or from the website www.utm.ro from the 2024 ADMISSION menu, by accessing the online registration button. Candidates undertake responsibility for the accuracy of the data and for the conformity of the scanned documents with the originals.
- (3) Candidates who are foreign citizens, Romanians living abroad, refugees, stateless persons and those under subsidiary protection in Romania and Romanian citizens with studies in other educational systems may apply exclusively online, according to the Regulation provided for in art. 1 para. (3).
- (4) Candidates who have been admitted through the online application procedure are required to submit in person the documents provided for in art. 36 of this Regulation, in paper format, to the faculty secretary's office, in the case of candidates who attended high school/university studies in Romania in the national education system, or to the International Relations Department at Calea Văcărești 189, Corp M, in the case of candidates who attended high school/university studies outside Romania or in Romania in another education system.
- (5) In order to comply with the legal provisions in force regarding the regime of study documents in the Romanian university education system, all candidates shall be registered for the admission examination with the name from the birth certificate. In case the name from the birth certificate has been changed, the name from the identity card shall be written in brackets in the list of registered candidates.
- (6) By way of exception to paragraph (4), candidates who are third-country nationals (non-EU) will be registered for the admission examination using the name on their passport.
- (7) If the candidate's surname and first name on the baccalaureate diploma/bachelor's degree or equivalent are not identical to the surname and first name as they appear on the identity card and/or birth certificate, the candidate is required to submit a supporting document, such as a marriage/divorce certificate, an order mentioning a change of name, an explanatory note provided by the embassy/consulate or other official document.
- Art. 35 (1) In accordance with the legal provisions in force, the requirement to submit certified copies of the candidate's original documents with the application file for the admission examination is abolished. Copies of the original documents, brought by the candidate or made within the TMU, certified for conformity with the original by the secretary who carries out the registration, shall be submitted to the file.
- (2) For the certification procedure, candidates must submit the original documents. After certification of conformity with the original, the original documents will be returned to the candidate,

except for the educational documents (baccalaureate diploma, bachelor's degree), which, in the case of successful candidates, will be kept on file for the duration of their studies.

- (3) It is forbidden to certify documents other than the originals.
- (4) Certification shall be made by comparing the original document with its copy and affixing to the copy a stamp "according to the original", followed by the surname and first name in clear script of the secretary making the certification, his/her holograph signature and the date on which the certification was made.
 - (5) If the candidate submits certified copies, these will be accepted.
- Art. 36. The documents required for registration, in printed form, put inside an envelope-type folder, on which candidates must write, in block capitals, the surname, initial(s) of the father's (mother's, if the father is unknown) first name(s), as well as the e-mail address and telephone number or online, scanned (if applicable), accompanied by the above-mentioned data:
- (1) **Bachelor's degree programme** (also including Medicine, Dental Medicine and Pharmacy programmes jointly comprising the 1^{st} and 2^{nd} cycles):
- 1. Standard application form for admission examination and enrolment to the bachelor's degree programme for the academic year 2024-2025, from the faculty Secretary's Office/generated online);
- 2. Identity card, in original and copy, in case of documents issued in Romanian, English, French or Italian and notarized sworn translation, in original, in Romanian, in case of foreign citizens whose documents are in another language than the mentioned ones;

- (2) If they are declared admitted to bachelor's degree programme, the candidates referred to in paragraph (1) are required to submit, by 30 September 2024, to the faculty secretary's office, their original and certified or certified true copy of their baccalaureate diploma.
- (3) In case they are declared admitted to master studies, the candidates mentioned in para. (1) shall submit their bachelor's degree diploma in original and certified or certified true copy to the faculty secretary's office within 12 months.
- (4) Failure to submit the original baccalaureate/bachelor's diploma due to the fault of the admitted candidate, within the time limits provided for in paragraph (2) and (3), shall cause the candidate to be expelled.
- (5) In case of loss or damage of the baccalaureate / bachelor's diploma, the candidate can be enrolled on the basis of supporting documents proving that all legal formalities concerning the preparation of a duplicate diploma have been fulfilled (notice in the Official Journal of Romania

- Art. 38. (1) The registration for the admission examination by physical presence of the candidates who have completed secondary school/university studies in Romania in the national education system is done at the headquarters of the University faculties in Calea Vacaresti nr. 187 (Faculty of Psychology, Faculty of Law) and nr. 189 (Faculty of Informatics, Faculty of Economic Sciences, Faculty of Educational Sciences, Communication and International Relations), Bd. Gheorghe Sincai nr. 16 (Aleea Borcea) (Faculty of Pharmacy), Strada Gheorghe nr. 67A and 67B (IOR) (Faculty of Dental Medicine and Faculty of Medicine), Targu Jiu, Bd. Ecaterina Teodoroiu nr. 100 (Faculty of Law and Economic Sciences Tg. Jiu, Faculty of Nursing Tg. Jiu), between 9:00 a.m. and 4:00 p.m. on working days, and on Saturdays between 9:00 a.m. and 2:00 p.m.
 - (2) Upon registration, the candidate shall receive a file registration number.
- (3) The secretary in charge of registration shall confirm the registration of candidates only if there is proof of payment of the application fee for the admission examination.

CHAPTER VI - Conduct of examination tests

Article 39. For the bachelor's degree programmes of the Faculty of Medicine and the Faculty of Dental Medicine (including the Medicine, Dental Medicine and Pharmacy university programmes), the Faculty of Pharmacy, the Faculty of Psychology and the Faculty of Nursing Târgu Jiu, the admission examination shall be conducted as follows:

- (1) The examination shall be held in person, on the same date as provided for each admission session and under the same conditions for all candidates enrolled in the same study programme, in compliance with all the rules of physical distance and other health regulations in force on the examination date.
- (2) The admission committee at the faculty level shall post on the notice boards of the faculty/on the admission web pages of the faculty, on the website www.utm.ro the anonymized lists (using the anonymization algorithm provided for in Article 46) with the allocation of candidates to the examination rooms at least 24 hours before the date of the admission examination.
- (3) Candidates are required to check the accuracy of the data entered in the posted lists and to notify the admission committee, through the faculty secretary's office, of any discrepancies. After the start of the examination, no changes will be made to the lists displayed.
- (4) Candidates are allowed to enter the examination rooms one hour before the beginning of the examination and are admitted on the basis of their identity card and the list posted on the door of the room, under the supervision of the teaching staff assigned to the room. After the time set for the start of the written test, candidates are not allowed to enter the rooms.
- (5) Candidates are not allowed to enter the examination room with any technical means of information and communication.
- (6) Candidates are seated in the examination room in alphabetical order and at a distance of one place from each other, according to the examination cards affixed to the desks.
- (7) The Committee for the preparation of the examination topics and the marking scales shall draw up at least two sets of examination topics, which shall be placed in envelopes stamped with the faculty stamp, signed by the chairman of the admission committee per faculty and kept in safe custody at the dean's office.

- (8) On the day before the examination, the faculty admissions committee, together with the committee for the preparation of the topics and the marking scales, shall draw lots for a set of topics for the multiplication of the question books/ lists.
- (9) The question books/lists shall be placed in envelopes labelled by room, stamped with the faculty stamp and signed by the chair of the faculty admission committee.
- (10) The Faculty Admissions Committee is responsible for the security of the envelopes containing the question books/lists until they are distributed in the examination rooms.
- (11) The Chairperson of the Faculty Admission Committee shall hand the envelope containing the question books/lists to the room head, who shall unseal the envelope in front of all candidates in the room, after allowing any candidate who so wishes to check the integrity of the stamp and signature on the envelope. Candidates who are not in the room at the time of unsealing the envelope containing the question books/lists, lose the right to take the relevant test.
- (12) The duration of the examination shall not exceed 3 hours from the time the distribution of subjects is completed. The room head shall clearly post and inform candidates of the starting and finishing times of the examination.
- (13) During the examination it is forbidden for candidates to communicate with each other or with the supervisors.
- (14) Candidates who violate the prohibition in paragraph (5), as well as those who attempt to cheat the examination, will be eliminated from the examination room and the paper will be marked 1 (one), and the concerned candidate no longer has the right to apply and participate in the admission examination within any study program organized by TMU, for 2 academic years. The room head will write on the list of candidates "excluded from the examination" opposite the name of the candidate found in one of these situations, being forbidden to apply and participate in the admission examination within any study program organized by TMU, for 2 academic years and will draw up a report signed by the room head and the candidate concerned; if the candidate refuses to sign, the report will be countersigned by one of the supervisors.
- (15) Leaving the examination room during the examination for physiological reasons, with the declared intention of returning to the examination room, may only be done by having one of the supervisors accompany the candidate; this situation may not extend the duration of the examination.
- (16) The candidate may not leave the examination room for good until at least 30 minutes after having been informed of the subjects and after having handed in the answer form and signed the roll of names held by the room head.
- (17) Answer forms must be filled in without erasures or corrections that could lead to misinterpretation, according to the following rules:
 - a) dark blue pen/pencil must be used for filling in; the use of erasable pens is prohibited;
- b) in order to mark the answer(s) considered to be true, in the case of questions with two true answers, tick the box(es) concerned with an X and leave the other boxes blank.
- (18) Candidates who wish to transcribe their work may do so only within the time limit set for the examination. To this end, those concerned will be given new answer forms and those used initially will be cancelled on the spot by the room head; the cancelled answer forms will be handed over to the committee and their contents will not be taken into account.
- (19) Only paper sheets with the faculty stamp received from the supervisors may be used for the draft.
- (20) At the end of the time allowed for the examination, candidates will stop writing and will remain in their places, waiting to be called for the answer form. The candidate handing in the answer form shall show his/her identity card and sign for its handing in on the nominal roll held by the room head.

- (21) When taking the answer forms, the person in charge of the room shall check how they have been filled in. If it is found that a question has not been ticked or more than one box has been ticked, the room head cancels that answer in front of the candidate by crossing out a red horizontal line on the answer form.
- (22) The room head shall sign the answer form in the corner that is sealed after checking the accuracy of the candidate's name, the form header and the test symbol.
- (23) It is forbidden for the candidate to leave the room with the question book/list or any other documents received from the Supervisory Committee.
- (24) Candidates' drafts shall not be marked and must be submitted to the room head together with the paper for later destruction.
 - (25) At least three candidates must be present in the room when answer forms are handed in.
- (26) The marking scales must be posted in a visible place in the examination room during the examination.
- Art. 40. (1) Appeals concerning the content of the written questions or the marking scales shall be submitted to the faculty admission committee within 2 hours after the written examination. After this deadline, it is no longer possible to challenge the content of the written questions or the marking scales.
- (2) The appeals referred to in paragraph (1) shall be examined by the Faculty Admission Committee, assisted, if necessary, by other specialists from the faculty. If, after examining the appeals, the Committee finds that there are questions containing wording errors or that there are errors in the marking scale/answer keys, the Faculty Admission Committee shall cancel the concerned questions and award, ex officio, the marks for those questions to all candidates. The decision is recorded in a report signed by all the members of the committee. The committee's decision is final.

Art. 41. After the written test, the following activities are carried out:

- a) the room head hands over the answer forms and the attendance sheet for supervisors (ANNEX 6) to the secretary of the admission committee by faculty, on the basis of minutes (ANNEX 5), together with all other documents resulting from the actual examination;
- b) the answer forms received by the secretary of the faculty admission committee are mixed, stamped and numbered;
- c) the stamped and numbered answer forms are handed over by the chairman of the faculty admission committee to the chairman of the written test marking committee under signature together with the marking slips (ANNEX 7) and the answer keys;
- d) each answer form is assessed independently by two members of the marking committee; the marks are recorded by each assessor on a separate slip, under his or her signature; if there are no discrepancies between the two assessments, the mark is recorded in the mark centraliser (ANNEX 8), signed by both assessors.
- e) if there is a discrepancy between the two assessments, the paper will be re-assessed by another member of the marking committee appointed by the chairman of the committee; the mark of the third assessor will be recorded on a separate marking slip, signed by the assessor, and will remain final; the mark of the third assessor will also be recorded in the mark book, under his/her signature.
- f) The marks/scores are entered on the answer forms with a red pen/pencil and signed by the chairperson of the faculty admission committee.
- g) the chairman of the faculty admission committee, having ascertained that all the procedures for evaluating the answer forms have been completed, shall unseal them. The members of the faculty admission committee calculate the overall admission average in accordance with the provisions of Articles 20-23, after which they fill in and sign the examination catalogue (ANNEXES 9-14).

- Art. 42. For the Informatics Bachelor's degree programme, the members of the faculty admission committee calculate the overall admission average in accordance with the provisions of art. 28, after which they fill in and sign the examination catalogue (ANNEX 12).
- Art. 43. For the Bachelor's degree programme from the Faculty of Law, the Faculty of Economic Sciences, the Faculty of Educational Sciences, Communication and International Relations and the Faculty of Law and Economic Sciences in Târgu Jiu, the members of the faculty admission committee calculate the overall admission average, after which they fill in and sign the examination catalogue (APPENDIX 13).
- Art. 44. For the Master's degree programmes, the members of the faculty admission committee calculate the overall admission average in accordance with the provisions of art. 30, after which fill in and sign the examination catalogue (APPENDIX 14).

CHAPTER VII - Completion of the admission examination

- Art. 45. (1) After the end of the admission examination and before any appeals against the results of the written tests, the admission committee for each faculty shall draw up at least two categories of lists: a) a provisional list of candidates declared admitted, in descending order of the overall average obtained in the admission examination, b) a provisional list of candidates declared rejected, in alphabetical order.
- (2) The lists referred to in paragraph (1) shall be signed by the Dean of the Faculty and endorsed by the Rector of the University, shall be issued in two versions: anonymised (using the anonymisation algorithm provided for in Article 45) and non-anonymised. The anonymised lists are posted on the faculty's ADMISSION web pages within 24 hours of the end of the admission session.
- Art. 46. (1) Appeals concerning the results of the written tests (score/mark) shall be sent to the email address of the faculty within 24 hours of the results being posted (starting from the time and date of posting). After this deadline it is no longer possible to challenge the results of the written tests. Candidates may only challenge their own results. In their appeal, candidates must state the name on their birth certificate, the initial(s) of their father (or mother if the father is unknown) and their first name.
- (2) The appeals referred to in paragraph (1) shall be examined by the Committee for the examination and resolution of appeals concerning the results of the written tests. The results of the appeals shall be communicated to the e-mail address of the appellant or posted on the faculty website within 48 hours of the deadline for lodging the appeal. The committee's decision is final.
 - (3) For each appeal, a re-marking report shall be drawn up (ANNEX 15).
- (4) The results of the oral or skills tests may not be challenged. Appeals made by not knowing the Admission Regulation are not accepted.
- Art. 47. The faculty admission committee draws up the final lists of the examination results, generated after the resolution of appeals. The final lists shall be signed by the Dean of the Faculty and endorsed by the Rector of the University. The final lists shall be generated in two versions: anonymised

(using the anonymisation algorithm provided for in Art. 48) and non-anonymised. The anonymised lists are posted on the faculty's ADMISSION web pages and constitute the basis for enrolment.

Art. 48. (1) The algorithm for anonymising admission lists is as follows:

 N_1 = the initial of the candidate's surname from the birth certificate;

 N_2 = the initial of the candidate's second surname on the birth certificate (if applicable);

 I_1 = the initial of the candidate's father's first name;

 I_2 = the second initial of the candidate's father's first name (if applicable);

 P_1 = initial of the candidate's first name;

 P_2 = the second initial of the candidate's first name (if applicable);

XXXX = the last four digits of the candidate's Personal Identification Number (or other personal identification number in the case of foreign nationals).

- (2) The anonymised lists shall contain in the preamble an explanatory note, written in bold, on the anonymisation algorithm referred to in paragraph (1).
- Art. 49. (1) If, at the end of the September 2024 admission session and before the start of the academic year, there are vacant or unoccupied places in a study programme, the faculty board may decide to allocate these places to candidates who have been rejected in the admission examination for such programme, in descending order of the overall averages obtained in the admission examination, provided that these averages are at least 5 (five) in the case of bachelor's degree programmes and at least 6 (six) in the case of master's degree programmes.
- (2) By way of exception to the provisions of paragraph. (1), if there are still vacant places in a bachelor's or master's degree programme, the faculty management may decide to allocate these places to candidates who have been rejected in the admission examination for another programme in the same field of study, in descending order of the overall average obtained in the admission examination, provided that these averages are at least 5 (five) in the case of bachelor's degree programmes and at least 6 (six) in the case of master's degree programmes, and only if the selection criteria established by this regulation are met.
- (3) The implementation of the procedures referred to in paragraph (1) may also be carried out at the end of the July 2024 admission session by decision of the Faculty Board.
- (4) Changes in the implementation of the procedures referred to in paragraph (1) shall lead to the rectification of the final admission lists before the enrolment, by decision of the Rector, of the candidates declared admitted.
- Art. 50. (1) The enrolment of the candidates declared admitted after the admission examination shall be made by decision of the Rector, provided that at least the first instalment of the annual tuition fee has been paid, in the amount and by the deadlines provided for in the Fee Nomenclature Regulation approved annually by the Board of Directors and the Senate of TMU.
- (2) Enrolment decisions can also be issued at the end of the summer admission session, under the condition provided in para. (1), respectively the payment of at least the first instalment of the annual tuition fee.
- (3) After registration, the final lists of admitted and enrolled candidates are generated and displayed.
- (4) After the approval of the enrolment, students are registered in the Romanian Unique Matriculation Register (RMUR), until the commissioning of the Integrated National Unique Register of Diplomas and Certificates of Studies (RUNIDAS), under a unique number, valid for the entire period of tuition in the study programme to which they have been admitted.
- Art. 51. The TMU is required to draw up and sign study contracts between enrolled students and the Rector of the TMU, represented by the Dean of the Faculty. The study contract, filled in and signed by each admitted and enrolled candidate, can also be submitted online, being required to submit the original by the beginning of the academic year.

CHAPTER VIII - Final provisions

Article 52. The files of unsuccessful candidates shall be returned, free of charge, within no more than 48 hours from the submission of a request in this regard.

Article 53. Applications and answer forms (where applicable) shall be kept in the files of admitted and enrolled candidates and shall have the same retention period as their files, and those of unsuccessful candidates shall be kept for one year after the end of the examination.

Art. 54. (1) After each admission session, the faculties shall compile an admission file for each study programme, containing the following parts, as appropriate:

- 1. excerpt from the Rector's decision appointing the examination committees;
- 2. the examination topics and marking scales;
- 3. the nominal table of candidates;
- 4. the marking slips/ grids;
- 5. the mark centraliser;
- 6. electronic records of the examination tests, if applicable, in secure storage spaces and on secure memory drives, under the coordination of the IT Department;
- 7. the examination catalogue;
- 8. attendance sheet for supervisors;
- 9. the handover report of the filled in answer forms and other materials resulting from the examination.
- 10. The lists of the examination final results.
- (2) The time limit for keeping the admission file in the TMU archives is permanent.
- Art. 55. The application of this Regulation is based on the faculties' own regulations for organizing and conducting admission examinations.
