






CHAPTER I – General provisions

- **Art.1** (1) The present regulation regulates the registration of candidates who are citizens of EU, EEA, Swiss Confederation, third countries (NON-EU), Romanians living abroad, refugees, stateless persons and those under subsidiary protection in Romania, as well as high school/university graduates from international systems accredited and recognized by the Ministry of Education for admission to undergraduate and postgraduate programs of Titu Maiorescu University.
- (2) The provisions of this regulation concern the conditions and documents required for application, including the conditions and procedure for recognition and equivalence of diplomas obtained in education systems other than the national system; as well as other useful information for candidates.
- (3) The provisions of this regulation complement the Regulations for the organization and conduct of admission to bachelor's degree, master degree, to the psycho-pedagogical study programs, to the postgraduate study programs and to the Romanian language preparatory program for the academic year 2024-2025 and the admission regulations developed by each faculty, as well as the special regulations developed by the Ministry of Education regarding the admission and schooling of Romanians abroad and foreign citizens.
- **Art. 2.** (1) The admission examination for Romanian-taught degree programmes shall be held in Romanian. The admission examination for university degree programmes taught in a foreign language is held in the concerned foreign language.
- (2) For study programmes which do not provide examination tests in the teaching language, additional language proficiency tests may be provided. The organization rules will be detailed in the faculty's own admission regulation.
- **Art. 3.** (1) Candidates to bachelor's degree, master degree and postgraduate study programmes in Romanian who do not submit academic documents issued by Romanian or foreign educational institutions teaching in Romanian are required to submit a language proficiency certificate for Romanian, minimum level B1 issued by institutions authorized by the Ministry of Education, or the graduation certificate for the preparatory year of Romanian language.
- (2) The following are exempt from the provisions of paragraph. (1) Romanian citizens who have studied in an education system other than the national one and who have taken a Romanian language test in the baccalaureate examination or who have studied Romanian for four years in secondary school.
- (3) For candidates who have studied in Romania in an international language or in a language of national minorities, the certification of Romanian language proficiency is done by the baccalaureate diploma. If the baccalaureate exam does not contain a test of oral communication proficiency in Romanian, graduates are required to submit a certificate of language proficiency for Romanian, minimum level B1, issued by institutions authorized by the Ministry of Education.
- (4) Candidates who have won prizes in national Romanian language Olympiads are exempted from the obligation to submit a certificate of proficiency in Romanian.
- **Art. 4.** (1) Candidates to English language study programmes are required to submit an internationally recognised English language certificate: Cambridge, INTERNATIONAL ENGLISH LANGUAGE TESTING SYSTEM (IELTS), TEST OF ENGLISH AS A FOREIGN LANGUAGE (TOEFL) or another certificate from the list of those recognised by the Ministry of Education.
- (2) If an internationally recognised English language certificate is not available, candidates for English language study programmes are required to submit a certificate of English language proficiency, minimum level B1, issued by authorised institutions of the Ministry of Education.


- (3) Candidates who are nationals of countries where English is the official language or who have documents proving that they have completed their secondary education in English are exempt from the requirements laid down in paragraph (1) and (2).
- **Art. 5.** TMU will inform candidates of the admission time table, the conditions and documents required for registration, including the conditions and procedure for the recognition of diplomas obtained abroad, the annual tuition offer, the examination tests, the subjects and bibliography of the admission examination, special facilities or conditions (including for people with disabilities, specific learning difficulties or special needs), the admission and tuition fees, as well as other useful information for candidates, by posting them at the faculties' premises and on the web page www.utm.ro. Information will also be published in English for English-taught degree programmes.

CHAPTER II - Candidates for admission

- **Art. 6**. (1) Only high school graduates with a baccalaureate diploma issued in Romania or a diploma equivalent to it, regardless of the year of their high school graduation, may apply for admission to the bachelor's degree programme.
- (2) The list of high school diplomas recognised by the Ministry of Education for the registration of foreign citizens to bachelor's degree studies is given in Annex 1.
- (3) Only graduates of bachelor's degree studies, with a bachelor's degree awarded in Romania or a degree equivalent to it, regardless of the graduation year, may apply for admission to the master's degree and postgraduate programmes.
- **Art. 7**. (1) Candidates who are Romanian citizens or EU citizens and who have graduated from high school education in international systems accredited and recognized by the Ministry of Education have the right to participate in the TMU admission process, starting on the high school graduation year, on the basis of the high school graduation certificate mentioning the final results of the high school graduation exam.
- (2) If the graduation certificate contains only partial results from the high school graduation exam, candidates may apply only to those study programmes which do not take into account baccalaureate marks / averages or equivalent in calculating the admission average. If baccalaureate marks / averages or equivalent are required for selection, partial baccalaureate marks / averages cannot be taken into account.
- (3) If admitted, candidates referred to in paragraph (2) will submit the equivalent international baccalaureate diploma no later than 6 months after admission.
- **Art. 8**. (1) Nationals of the European Union Member States, of States belonging to the European Economic Area and of the Swiss Confederation, and British nationals and their family members, as beneficiaries of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community 2019/C 384 1/01, refugees, stateless persons and those under subsidiary protection in Romania may participate in the admission to bachelor's and master's degree programmes and postgraduate programmes under the same conditions as those provided by law and by this methodology for Romanian citizens, including the admission application and tuition fees. For these categories of citizens, the recognition of studies is done by the National Centre for the Recognition and Equivalence of Diplomas of the Ministry of Education.
- (2) Foreign citizens from third countries may apply for the admission examination by paying the fee in their own foreign currency, on the basis of a request for obtaining a letter of acceptance to study in Romania, issued by the Directorate General for International Relations and European Affairs of the Ministry of Education.


- (3) Romanians abroad may participate in the admission to bachelor's degree, master's degree and postgraduate study programmes, under the same conditions provided by law and by this regulation for Romanian citizens, including the application fee and the tuition fee. For these categories of citizens, the DGRIAE Romanians Abroad shall issue a tuition approval.
- **Art. 9.** (1) The candidates mentioned in art. 8, declared admitted to bachelor's degree, master's degree and postgraduate study programmes, can be enrolled only on the basis of their baccalaureate or bachelor's degree, respectively, recognised in accordance with the regulations developed by the specialised directorates of the Ministry of Education.
- (2) Pending receipt of the documents attesting to the recognition of studies from the Ministry of Education, the candidates referred to in Article (1) will be provisionally enrolled subject to receipt of the documents attesting to the recognition of studies/acceptance of studies/approval of tuition.
- **Art. 10**. (1) The International Relations Department (DRI) of Titu Maiorescu University shall make the necessary arrangements with the specialized departments of the Ministry of Education for the recognition of the studies of the candidates admitted to the university study programs.
- (2) If candidates have such recognition documents, they will be included in the admission file submitted with the application.
- (3) In the case of failure to issue documents concerning recognition of studies / acceptance to studies / approval of tuition by the Ministry of Education directorates, the student shall be expelled.
- **Art. 11.** Candidates registered in the admission examination with the nationality of a third EU state and who, as students, obtain Romanian nationality during their university studies shall pay the tuition fee established by the Fee Nomenclature Regulation for students from third EU states.
- **Art. 12.** As an exception to the provisions of art. 11, in case of change of citizenship status, upon the student's request, duly motivated, approved by the Vice-President responsible for international relations, the Board of Directors may approve the payment of the tuition fee for Romanian citizen students, established by the Fee Nomenclature Regulation.

CHAPTER III - Equivalence of marks obtained in other education systems

- **Art.13.** (1) Admission is made by study programmes and forms of education, in descending order of the overall averages obtained by the candidates in the admission examination, within the limit of places established by ARACIS and provided by the GD for the academic year 2024-2025.
- (2) If for a study programme TMU receives approval from the Ministry of Education for an additional number of places for the registration of European citizens or third country EU citizens or for academic mobility of students within the limit of 10% of the places established by ARACIS for the programme in question the places will be taken only by candidates who have passed the admission examination, as follows: within the number of places established by ARACIS for Romanian citizen candidates and within the additional number of places approved for foreign citizen candidates.
- **Art. 14.** (1) The tests of the admission examination are presented in the Admission Framework Regulation and in the Admission Regulations for each faculty.
- **Art. 15.** (1) In the case of candidates who have completed their high school/university studies outside Romania or in Romania in an education system other than the national one, the general average of the baccalaureate or equivalent examination, the marks obtained in the first foreign language during high school studies and the general averages obtained in the bachelor's degree examination shall be equated in the Romanian marking system by the Committee for the equivalence of marks obtained in other education systems, appointed by decision of the President.


- (2) Equivalence is based on the documents submitted in the admission file application form, baccalaureate diploma or equivalent, transcript, bachelor's degree.
- (3) Equivalence is carried out only for those marks / averages that are relevant in calculating the overall admission average or as criteria for admission to the study programme to which the candidate has applied.
- (4) The Equivalence System of marks obtained during high school studies Annex 2 is made by the Equivalence Committee as follows:
- a. The minimum criteria for passing the examinations and admission to tertiary education in the educational system of the country of reference are taken into account according to the Information Guide Foreign Pre-University Level Marking Systems, developed by CNRED. These relate to the minimum passing criterion (minimum mark/average of 5.00) and the minimum criterion for admission to Romanian higher education (minimum baccalaureate average of 6.00; minimum bachelor's degree / master's degree average of 6.00).
- b. The conversion of marks /averages is done by relating the marks in the Romanian grading system (average with two decimal places) to the marks in other educational systems, adjusted according to the distribution of performance in the concerned marking system.
 - c. The equivalence system is updated annually by the Equivalence Committee.
- (5) The equivalence system of the bachelor's average is made by the Equivalence Committee based on MECTS Order 3223 of 8 February 2012 concerning the Regulation on the recognition of study periods carried out abroad.

CHAPTER IV – Candidates registration

- **Art. 16.** (1) Registration for the admission exam is exclusively online for candidates who are citizens of the European Union Member States, the European Economic Area and the Swiss Confederation, candidates from third countries, Romanians living abroad, refugees, stateless persons and those under subsidiary protection in Romania, as well as Romanian citizens with studies in other educational systems.
- (2) Registration is carried out by uploading (scanned) documents by candidates on the TMU's 2024 ADMISSIONS portal, which can be accessed directly from the link https://admitere.utm.ro or from the website www.utm.ro from the menu ADMISSION 2024, by clicking on the online registration button.
- (3) Candidates assume responsibility for the accuracy, veracity and correctness of the data, including contact details (email address, telephone number), as well as for the correspondence between scanned and original documents.
- (4) Only documents uploaded electronically in the portal will be taken into account for the validation of the file.
- **Art. 17.** (1) In order to comply with the legal provisions in force concerning the regime of study documents in the Romanian university education system, all candidates shall be registered for the admission examination with the name on the birth certificate. If the name on the birth certificate has been changed, the name on the identity card shall be entered in brackets in the list of registered candidates.
- (2) By exception, candidates who are third-country (non-EU) nationals will be entered with the name in their passport.






- (3) If the candidate's surname and first name on the baccalaureate diploma / bachelor's degree or equivalent are not identical to the surname and first name as they appear on the identity card and/or birth certificate, the candidate is required to submit a supporting document, such as a marriage / divorce certificate, a decision for change of name, an explanatory note provided by the embassy / consulate or other official document.
- **Art.18** (1) Candidates declared admitted as citizens of the Member States of the European Union, of the countries belonging to the European Economic Area and of the Swiss Confederation, candidates from third countries, Romanians living abroad as well as Romanian citizens with studies in other educational systems shall submit their application forms to the **International Relations Department of** TMU (Corpul M, Calea Văcărești nr. 189, ground floor), in order to prepare and send the files to the Ministry of Education for the equivalence of studies by the National Centre for the Recognition and Equivalence of Diplomas (CNRED), respectively for obtaining the letter of acceptance to study from the Directorate General for International Relations and European Affairs (DGRIAE) and obtaining the approval of tuition from DGRIAE Romanians Abroad.
- (2) The fee for the treatment and forwarding of candidates' files to the Ministry of Education is set out in the Fee Nomenclature Regulation and is not refundable under any conditions.
- Art. 19 (1) In accordance with the legal provisions in force, the requirement to submit certified copies of the candidate's original documents with the application file for the admission examination is abolished. Copies of the original documents, brought by the candidate or made within the TMU, certified for conformity with the original by the specialized staff carrying out the registration, shall be submitted to the file.
- (2) For the certification procedure, candidates must submit the original documents. After certification of conformity with the original, the original documents will be returned to the candidate, **except for the educational documents (baccalaureate diploma, bachelor's degree),** which, in the case of successful candidates, will be kept on file for the duration of their studies.
 - (3) Certification of documents other than the originals is prohibited.
- (4) Certification is made by comparing the original document with the copy and affixing the stamp "true to original" to the copy, followed by the name and surname in clear script of the person making the certification, his or her handwritten signature and the date on which the certification was made.
 - (5) If the applicant submits certified copies, these are accepted.
- **Art. 20.** For the application stage, documents issued or translated into Romanian, English, French or Italian may be accepted. For registration purposes, the files submitted by successful candidates must include a certified translation into Romanian for all documents issued in another language.
- **Art. 21. The documents required for registration** will be submitted in scanned format via the admission portal. Successful candidates, for the purpose of registration, will submit / send in scanned format the documents listed below. The documents will be submitted in envelope-type folders, on which the candidates will write, in capital letters, the name, initial(s) of the father's (mother's, if the father is unknown) first name(s), and e-mail address and telephone number with the above mentioned details:
 - (1) Bachelor's degree programme:
 - 1. **Standard application form** for admission examination and enrolment to the bachelor's degree programme for the academic year 2024-2025, generated online;






- 2. **Request for recognition of high school diploma** by the CNRED/DGRIAE/DGRIAE-RP, generated online;
- 3. **Identity card**, in original and copy, in case of documents issued in Romanian, English, French or Italian and notarized sworn translation, in original, in Romanian, in case of foreign citizens whose documents are in another language than the mentioned ones;
- 4. **Baccalaureate diploma** in original and notarized sworn translation into Romanian, according to the List of high school diplomas recognized by the Ministry of Education found in Annex 1. Candidates who are students at another faculty must submit a copy or a certified copy of their baccalaureate diploma, accompanied by a student certificate stating that the original of the diploma is kept with the student's file. Diplomas issued in other countries must be endorsed with the Hague Apostille or subject to consular legalization, according to the rules established by the Ministry of Education in the Regulation for the admission to studies and schooling of foreign citizens, found in Annex 3.
- 5. **School transcript** for all years of high school, in original and copy, in the case of documents issued in Romanian, English, French or Italian, and notarized sworn translation into Romanian, in original, in the case of foreign citizens whose documents are in a language other than those mentioned.
- 6. **Affidavit** stating that the candidate does not pursue more than two bachelor's degree programmes concurrently, regardless of the degree and of the higher education institutions offering them (enclosed with the application form);
- 7. **Birth certificate**, the original copy and photocopy, in the case of documents issued in Romanian, English, French or Italian. In the case of foreign citizens whose documents are in a language other than those mentioned, a notarized sworn translation into Romanian (the original copy) must be submitted;
- 8. **Marriage certificate** (if applicable), the original copy and photocopy, in case of documents issued in Romanian, English, French or Italian. In case of foreign citizens whose documents are in a language other than those mentioned, a notarized sworn translation, in original, into Romanian must be submitted;
- 9. The original copy and a photocopy of the **divorce certificate** or of **a name changing proof** (if applicable), in case of documents issued in Romanian, English, French or Italian. In case of foreign citizens whose documents are in another language than those mentioned, a notarized sworn translation, in original, into Romanian must be submitted;
- 10. **Declaration of belonging to the Romanian cultural identity of Romanians abroad** for foreign citizens who wish to apply as Romanians abroad available at the Department for Romanians abroad of the Romanian Ministry of Foreign Affairs or at the Romanian Embassy / Consulate in the country of residence
- 11. **Medical certificate** issued in the current year by a Romanian competent authority, medical certificate issued by a foreign competent authority in original copy for the ones issued in English, French or Italian, or a sworn *true to original* or notarized translation, in case the certificate is issued in another language than those mentioned, attesting the state of health at the time of examination, with the mention "*This certificate was issued for the purpose of registration at the university*";
 - 12. Three 3/4 size colour photographs;
- 13. **Certificate of language proficiency in Romanian**, issued by institutions authorized by the Ministry of Education, minimum level Bl, or a graduation certificate of the Romanian language preparatory Programme, in the case of foreign candidates applying for Romanian language study programmes, in compliance with the provisions of Article 3;
- 14. **Internationally recognised English language certificate**: Cambridge, INTERNATIONAL ENGLISH LANGUAGE TESTING SYSTEM (IELTS), TEST OF ENGLISH AS A FOREIGN LANGUAGE (TOEFL) or other internationally recognised certificate; certificate of English language proficiency, minimum level Bl, issued by institutions


- 15. **Candidate's information notice** on the personal data treatment and **Consent form** for the personal data treatment (GDPR).
- 16. **Affidavit** as to the accuracy of the data in the application form as well as the correspondence between scanned and original documents in case of online applications.
 - 17. Proof of payment of the application fee.

(2) Master's degree and postgraduate programme, including the Compact Teaching Training Programme, level I and level II:

- 1. **Standard application form** for admission examination and enrolment to the master's degree programme for the academic year 2024-2025 (generated online);
- 2. **Request for recognition of high school diploma** by the CNRED/DGRIAE/DGRIAE-RP, generated online;
- 3. **Identity card**, in original and copy, in case of documents issued in Romanian, English, French or Italian. In case of foreign citizens whose documents are in another language than the mentioned ones, a notarized sworn translation into Romanian, in original, shall be submitted;
- 4. **Baccalaureate diploma** in original and notarized sworn translation into Romanian, according to the List of high school diplomas recognized by the Ministry of Education found in Annex 1. Candidates who are students at another faculty must submit a copy or a certified copy of their baccalaureate diploma, accompanied by a student certificate stating that the original of the diploma is kept with the student's file. Diplomas issued in other countries must be endorsed with the Hague Apostille or subject to consular legalization, according to the rules established by the Ministry of Education in the Regulation for the admission to studies and schooling of foreign citizens, found in Annex 3.
- 5. **School transcript** for all years of high school, in original and copy, in the case of documents issued in Romanian, English, French or Italian, and notarized sworn translation into Romanian, in original, in the case of foreign citizens whose documents are in a language other than those mentioned.
- 6. Original and copy of **bachelor's degree**. Candidates who are students at another faculty must submit a certified *true to original* or certified notarized copy of their bachelor's degree, accompanied by a student certificate stating that the original of their degree is kept with the student's file. Candidates who have completed their university studies outside Romania or in a language other than Romanian must submit their bachelor's degree in original and a sworn notarized translation (in original) into Romanian. The conditions for apostille / consular legalisation are as above;
- 7. **Academic transcript** for all years of bachelor's degree studies, in original and copy, in the case of documents issued in Romanian, English, French or Italian, and sworn notarized translation into Romanian, in original, in the case of foreign citizens whose documents are in a language other than those mentioned.
- 8. **Affidavit** stating that the candidate does not pursue more than two master's degree programmes concurrently, regardless of the degree and of the higher education institutions offering them (enclosed with the application form);
- 9. **Birth certificate**, the original copy and photocopy, in the case of documents issued in Romanian, English, French or Italian. In the case of foreign citizens whose documents are in a language other than those mentioned, a notarized sworn translation into Romanian (the original copy) must be submitted;






- 10. **Marriage certificate** (if applicable), the original copy and photocopy, in case of documents issued in Romanian, English, French or Italian. In case of foreign citizens whose documents are in a language other than those mentioned, a notarized sworn translation, in original, into Romanian must be submitted;
- 11. The original copy and a photocopy of the **divorce certificate** or of **a name changing proof** (if applicable), in case of documents issued in Romanian, English, French or Italian. In case of foreign citizens whose documents are in another language than those mentioned, a notarized sworn translation, in original, into Romanian must be submitted;
- 12. **Declaration of belonging to the Romanian cultural identity of Romanians abroad** for foreign citizens who wish to apply as Romanians abroad available at the Department for Romanians abroad of the Romanian Ministry of Foreign Affairs or at the Romanian Embassy / Consulate in the country of residence
- 13. **Medical certificate** issued by a Romanian competent authority or a sworn *true to original* or notarized translation, if the certificate is issued by a foreign competent authority, attesting the state of health at the time of the examination, with the mention "*This certificate was issued for the purpose of registration at the university*";
 - 14. Three 3/4 size colour photographs;
- 15. Certificate of language proficiency in Romanian, issued by institutions authorized by the Ministry of Education, minimum level Bl, or a graduation certificate of the Romanian language preparatory Programme, in the case of foreign candidates, in compliance with the provisions of Article 3;
- 16. **Candidate's information notice** on the personal data treatment and **Consent form** for the personal data treatment (GDPR).
- 17. **Affidavit** as to the accuracy of the data in the application form as well as the correspondence between scanned and original documents in case of online applications.
- 18. Candidates' agreement to record the admission interview if the interview is held online
 - 19. Proof of payment of the application fee.
- (3) Teaching Training Specialised Department programmes (Level I during bachelor's degree studies Level II during the master's degree studies):
 - 1. **Standard application form** for admission examination and enrolment to the programme for the academic year 2024-2025 (generated online);
 - 2. **Identity card** in certified true to original copy;
 - 3. **Baccalaureate diploma** in certified true to original copy (for Level I during bachelor's degree studies);
 - 4. **Bachelor's degree** in a certified true to original copy (for Level II during the master's degree studies);
 - 5. **Birth certificate** in certified true to original copy;

- ➤ Copies of study documents issued by the authorities of the European Union, EEA and Swiss Confederation Member States (with the exception of Greece, Italy, Spain, Portugal and Cyprus) must be certified by the competent authorities of the issuing countries. The Hague Apostille is not required.
- ➤ Study documents issued in Greece, Italy, Spain, Portugal and Cyprus must be endorsed with the Hague Apostille.
- ➤ The certification of study documents with the Hague Apostille is carried out as follows: the ORIGINAL document (high school diploma or school leaving certificate) is apostilled and a translation of the original document is notarized / apostilled. If the study documents are written in languages other than Romanian, English or French, their translations must be notarised.
- ➤ For States which are parties to the Hague Apostille Convention, study documents subject to equivalence / recognition and birth certificates must be endorsed with the Hague Apostille by the competent authorities of the issuing countries.
- ➤ For States which are not party to the Hague Apostille Convention, diplomas must be subject to consular legalization. Consular legalization implies that the documents are endorsed as follows:
 - by the Ministry of Foreign Affairs of the country that issued the diploma, the Romanian Embassy/Consulate in the respective country and the Romanian Ministry of Foreign Affairs.

Or

- by the Ministry of Foreign Affairs of the issuing country, the Embassy / Consulate of the respective country in Romania and the Ministry of Foreign Affairs of Romania
- For countries where there are no diplomatic representations of Romania, the study documents must be endorsed by the Ministry of Education and the Ministry of Foreign Affairs of the issuing country.
- Exemption from consular legalisation is allowed by law, by an international treaty to which Romania is a party or on a reciprocal basis.
